

All 20 Questions from my ACTUAL FIFA Agents Exam.

Hi Football Agents! I did something I am really proud of to help you on your way to becoming a licensed Football Agent.

As you know the **FIFA agents exam** follows a standard format, you are presented with **20 questions** and you have 1 hour to complete the exam. Each question is worth a point, and you need at least **15 points to pass**. I personally took the exam in September 2023, I wrote down all the questions I had shortly after leaving the exam venue, and I am happy to share them with you.

Please remember that each person gets different questions, so you WON'T get the same questions below, but they are good preparation material. I passed the exam but I am not writing the answers down here so folks can practice finding the answers in the study material, just like what you will be doing in the real exam, which is an open book exam. Enjoy practicing!

All the answers are presented as multiple choice and you have to choose the write answer(s).

1. What does **EPP** stand for in the context of FIFA regulations? (Choose one)
2. Can FIFA **sanction** Football **Agents** who fail to comply with **Article 5bis**? (Yes or No.)
3. What is a **bridge transfer** as defined in FIFA regulations. (Choose all that apply)
4. Name two entities who you could **report a safeguarding** concern to. (Choose one)
5. **Scenario Question**: You observe a coach at a football academy engaging in behavior that raises **safeguarding** concerns, such as inappropriate interactions with young players. What action should you take in relation to reporting this practice? (Choose one)
6. What are the **sanctions** for a club or member association that fails a **First Compliance Assessment**? (Choose all that apply)
7. What **sanctions** can a Member Association face if they fail to accurately **review the EPP**? (Choose all that apply)
8. Are **club officials** eligible to operate as football agents? (Yes or No.)
9. **Scenario Question**: You are given a scenario involving an agent representing **more than one player at the same club**? The question: Is this practice allowed under **FFAR**? (Yes or No.)

10. Is it allowed under FFAR for a **Representation Agreement** to have an **automatic extension** clause?
11. What are the **requirements** for **Representation Agreements** to be valid? (Choose all that apply)
12. **Scenario Question**: An association wants to be admitted as a FIFA member without being a member of a confederation first. Will FIFA membership be granted in this case? (Yes or No.)
13. How is an **agent's fee** calculated when representing an **Engaging Entity**?
14. Does the agent's fee calculation include sell-on fees? (Yes or No.)
15. **Scenario Question**: Your client, a player you represent, has been subject to **disciplinary action** by the disciplinary committee and has been fined **CHF 5000**. **The player requests you to appeal the decision**. Are you allowed to appeal the decision before the appeal committee? (Yes or No.)
16. **Female players** are entitled to **maternity leave** during the term of their contract, paid at the equivalent of **How much** of their contracted **salary**? (Choose one)
17. **Scenario Question**: Can clubs **directly contact** your client during transfer deadline day? (Yes or No.)
18. Can **member associations** set different **registration periods** for lower divisions?
19. What should **players** do first when facing **overdue salaries** from their clubs? (Choose one)
20. Who is responsible for maintaining **order and security** in and around stadiums on **match days** according to FIFA regulations? (Choose one)
